It for a livelihood perfect gentlemen? Is not boxing one of the studies of all the high schools in Australia? How many boys would join the class if you had boxing in the high school here? Preparing the body for war do not the boys have to go through the same exercise as on training for a boxing contest? How long would it take a boxer to get ready to stand the hardships of war? How long would it take one who has never had the training of a boxer? Why do they still call boxing contests prize fights?

"If all boys knew how to handle themselves with the gloves, do you think they would resort to firearms in case of trouble. Don't you think it is far better to see men settle their disputes with their fists, instead of swords or pistols? Don't the parents admire a boy who can hold his own with any other boy? Do all the boys who take up boxing want to follow it for a living?"

"How many women have ever seen two clever boxers engage in a sparring match? If they did how many of them do you think would uphold it?"

"How do all the boys in the U. S.

army and navy settle their trouble? "Did not Col. Roosevelt, when he was president of the United States have a boxing instructor give him lessons?"

"What I am trying to do is to get before the people what good results one gets from taking-up boxing when he is young. I will just put my case before them. When I was 16 years old my folks thought I was going into consumption, I was very slim and only 95 pounds. The doctors told my mother to send me to Arizona as the change of climate would do me good. A neighbor of our's told my father to send me to an athletic club, which my father did. In two years' time I was as strong and healthy as any boy could have been and not only that I had won the featherweight championship of the United States as an amateur. When I was in that club less than three years I won the lightweight championship of the Pacific coast. To win that contest I had to fight two nights 76 rounds one night and 15 the next. Then I weighed 133 pounds. Does that look like boxing has done me any good? Since that time I have never had any need for a doctor's advice. I am 44 years old now and I know I can work as hard all day and not get tired out as any young fellow half that age. Boxing some day is going to get before you in the right light."

Yoser outweighed Conrad by at least 10 pounds but Conrad stuck to the guns like a game soldier for four rounds and the referee gave him the decision. stepped into the ring and challenged any man in the country in behalf of some big colored middleweight he brought over.

Young Coggins and Kid Davidson next stepped into the ring. The first round was a peach. The second was equally good, the boys fighting like two game rocks and on through the third when they both tried for a knockout. It was in the fourth round that Davidson got in some telling blows that earned for him the decision.

The third contest brought together Ad Schaffli and Jimmie Maloney. Maloney went down in every round and was counted out in the third.

Red Egan and Ed Hunter went at it slowly and they hugged frequently. The rounds were about even, with few exchanges of good blows. Egan kept trying all the time, in his typical manner. But he failed to land many of his terrific right hand swings. The draw decision met with the approval of the spectators.

## HIS GLOVES STOLEN, JOE USES THIN RIDING GLOVES

### Memorable Battle Fought on a Barge After Sheriff Had Stopped First Fight.

While in a reminiscent mood the other night, Freddie Bogan, famous boxer, trainer and promoter was asked to name the greatest battle he ever witnessed, and he has seen probably 1,000 prize fights, and he told one of the most interesting stories of the ring.

This one took place away back in May, 1889 in California, when they battled to a finish with two ounce gloves, straight Marquis of Queensberry rules. It was between James J. Corbett, former heavyweight champion, and Joe Choynski. They were both young men at the time; Corbett was clerk in the Nevada bank in San Francisco, and also instructor at the Olympic club. Choynski was working at his trade, making candy. They were both in the heavyweight class, went to the same school, having been born in the same block on Hayes street and were fast friends, until they entered the ring.

Boyhood friends

Choynski was the first to turn professional. He met and defeated Frank Glover at the California club in San Francisco for a \$1,500 purse. Corbett then, pro., and he was beating them as fast as they came along. Finally a jealous feeling commenced to leak out of both boys. So one day they got together and arranged a match to fight in private for \$1,000 a side. The California club offered them a good purse, but the directors of the Olympic club told Corbett if he fought in that club he would lose his position as instructor. The ones who knew about it were kept on the anxious seat for a week, to get the tip where the battle was to take place. Finally one night we received word to go to Sausalito the next day at noon and from there we would learn where the battle ground was located.

About 400 of us walked about ten miles. At last we came to a large barn. The backers of both men rented it and some of the boys got busy at once pitching the ring and getting things ready.

Searched for Guns

In about an hour a big fellow spoke up and said: "If any one wants to get in to see this scrap he will have to be searched for fire arms, as this is going to be a fair fight and the best man is going to win." Well, you would have been surprised to see how they just walked up to the big fellow and handed him their guns, most every one

# Not Settled

New Compilation of Game and Fish Laws Does Not Settle the Question: "Is a Perch a Bass?"

The new book of annotated game and fish laws prepared and sent out by L. H. Darwin, state game warden does not settle the question propounded at Lake Stevens, "Is a perch a bass?" The laws distinguish perch and bass in every way, except that no mention is made of the length of perch.

It says: "Unlawful to at any time take any trout or bass of any variety which are less than 10 inches in length." Yet perch is not defined by the law, or the laws of nature, as a variety of bass.

There are some interesting doubts in the new code summary. Among them are that it is unlawful:

To hunt or fish without first having secured a license.

To fish for game fish except with hook and line.

To dynamite fish, to put poison including medicated bait or other matter deleterious to fish in any body of water.

To kill for hides or horns.

To shoot from any launch or power boat, or hunt water fowl after sunset or before sunrise, or use any gun other than one fired from the shoulder, or to use any sneak boat.

To set steel trap larger than No. 4 without posting notice.

To rob any nest of its eggs.

To refuse to permit warden to inspect bag or creel, or to sell game birds, fish or game animals.

To shoot in any river, lake or body of water, or to run deer with dogs.

To kill seagulls or any non-game bird.

there was heeled. When everyone was inside, the referee spoke up and said: "Gentlemen: this is going to be a finish fight and should it be stopped through any interference, I am going to name a date in the near future for it to be finished. He said both men were willing to accept him as referee and he was going to see to it that both got fair play.

### Sheriff Stops It

The battle started and at it they went. It was some fight. In the fourth round one of the look-outs shouted: "Sheriff." The men at their corners, took off the two ounce gloves and put on eight ounce, and just got up when the bell rang and stood there, looking at each other. The sheriff came in, examined the gloves, got out of the ring and stood there waiting to see them go at it. But instead, when time was called, they both took off the gloves put on their clothes and we all started home.

Four days after, we got the tip to go to Benica. When the train arrived everything was in readiness as some of the boys had gone ahead and arranged it so there would be no delay. They had pitched the ring on a large barge. All told, there must have been close to 1,000 on the second meeting. For fear of any interference they got in the ring as fast as they could.

### Joe's Gloves Stolen.

While waiting in their corners, Corbett walked over to Choynski and asked: "Where are your gloves?" Choynski replied he didn't know who had them. He said he was waiting for them. Corbett said: "You can use your bare fists. I can lick you anyway. Some one produced a pair of driving gloves. They cut part of the fingers off, and all was ready. Time was called and at it they went.

It was one of the toughest battles ever fought in the prize ring. Before they went ten rounds they were both covered with blood. Two big, game, clever fellows, just battling as hard as nature would let them. Both of them would rather have been killed than lose.

Finally, Corbett took the lead, and kept jabbing Joe until the poor fellow could hardly stand. In the 27th round Jack Dempsey, Choynski's second, tossed the towel into the ring. Instead of Joe losing any friends that battle made one of the most popular fighters who ever donned a glove.

Those were the days of real fighting.

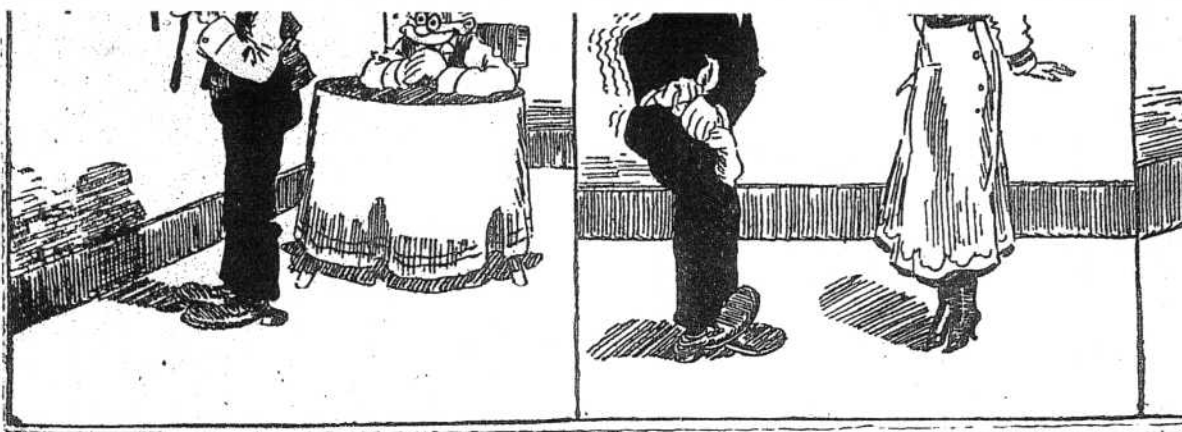

LaBlancie Withstands Terrific Punishment for 30 Rounds and Delivers Just One Hard Blow.

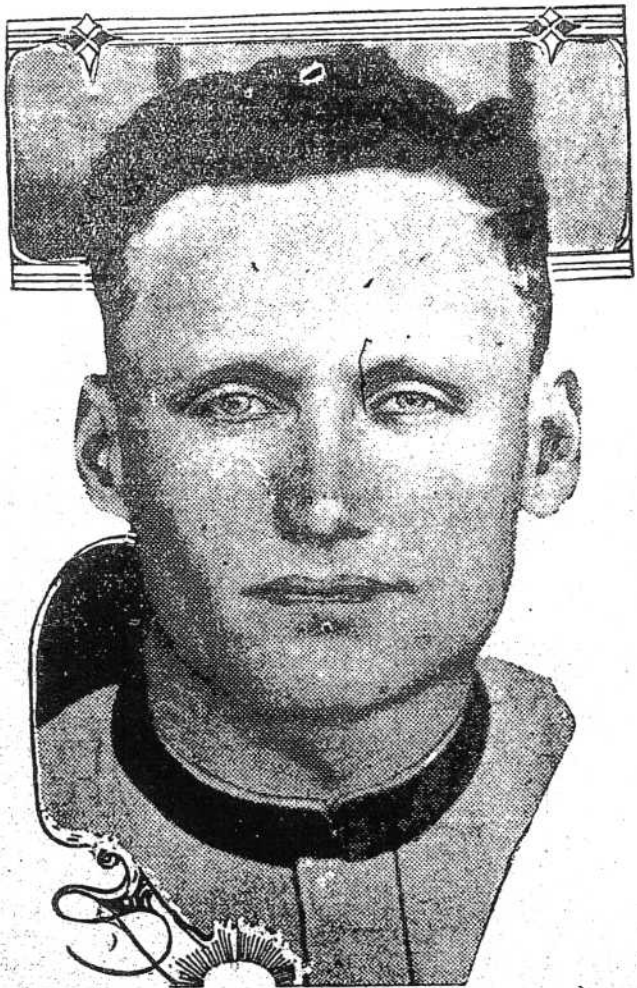

Jack Dempsey was the most popular fighter that ever stepped into the ring. He was known all over the world as the Nonpariel. He was middleweight champion of the world from 1884 until 1891. About the same time John L. Sullivan was heavyweight champion and Jack McAuliffe, lightweight champion. They were always chums and were known as the Three Great Jacks. Dempsey was loved by all for his sympathetic disposition and kind ways. He could never see any of his fellows in need. Dempsey gave to the poor in his time over half his earnings from the prize ring. Jack had a heart as gentle as a lamb, but was game as a lion. He fought nearly all his battles in London prize ring rules. He had won 50 battles straight under those rules, before they did away with them in 1889.

Dempsey was defeated in his first championship contest under Marquis of Queensbury rules, but he did not loose his title because his opponent George LaBlancie, came in overweight. Dempsey and LaBlancie fought for the largest purse up to that time ever offered two men. It

was \$5,500, \$5,000 to the winner and \$500 to the loser. They met in the California Athletic club in San Francisco, August 27, 1889.

### Admission Price \$27.50

The match was the talk over the whole country. They fought for the middleweight championship, which at that time called for the men to weigh in at ringside 154 pounds. You had to become a member of the club then to see the contest, which cost \$27.50. There were over 5,000 members present when the first contest was put on.

That night I boxed a 10-round contest with Spider Gallagher and was declared the winner by Hiram Cook, the same referee who later in the evening called off the 10 seconds over the fallen hero.

Almost every member that night held his breath as the men stepped into the ring. Two finer specimens of manhood never entered the ring. Dempsey was all smiles and bowing to some friends around the ring while putting on the gloves. LaBlanche had a firm look on his face. Hiram Cook called both men with their seconds to the center of the ring, and after they received instructions from him, he named the weights as Dempsey, 151 1-2 pounds, and LaBlanche, 163. The men shook hands and the bell rang, sending two of the greatest battlers in their time together. Dempsey at once started

to jab his left to George's face. He connected no less than 25 times during the round without receiving a return.

### Withstands Awful Punishment

By the tenth round LaBlanche's face was a sight to look at. But he kept on taking all Jack could give and came back for more. The people who saw that battle that night are still talking about Dempsey's wonderful left. When the gong rang for the 30th round one could not recognize LaBlanche from an Indian while Dempsey did not have a mark on him to show he was in a fight.

### Great Fighter Dropped

In the 31st round Dempsey started into end the battle. Right after George he went, sending him groggy every time he landed. In the middle of the round LaBlanche whirled around, and to the surprise of every one Dempsey fell flat on his face, the fall breaking his nose. Hiram Cook, the referee, was calling off the seconds. You could hear a pin drop, and when he raised LaBlanche's hand as a winner, many of the members shed tears.

### Pivot Blow Banished

Poor Dempsey got up unassisted in a couple of seconds after being counted out and begged George to go on with the battle. But LaBlanche just shook his head and walked to his corner. The blow that knocked Dempsey out was a pivot blow and was barred right after that battle.

### Dies of Broken Heart

Dempsey never got over that defeat and was never the same great fighter he had been. His battle with Fitzsimmons showed he had lost his pep and confidence. After the Fitz. contest, Dempsey started drinking to drown his sorrows, and in a few years died of a broken heart. I don't believe the ring will ever again see the equal of The Three Jacks in their prime.

# MONROE BECAME FAMOUS IN ONE ROUND OF BOUT

By Boxing the Fastest Round Ever Fought in Ring Against Jim Jeffries, Jack Monroe Won Fame.

Jack Monroe, the Canadian fighter who has been killed in a battle in France, came to San Francisco in 1890, a big, strong young fellow. The football game was all the craze in those years. Senator Clark from Montana came to San Francisco and selected a football team to represent Butte City, Mont. Among the players he selected was Jack Monroe. For two years the Clark football team traveled all over the United States and never met defeat. In the latter part of 1893 the football team disbanded. Monroe, a good, whole-souled fellow, was left in Butte, broke, looking for work. He worked off and on in the mines, making a living and that was all.

Monroe, in his younger days, did quite a bit of boxing in the amateur class. He won a medal for the heavyweight championship of the Pacific coast, along in 1893. The bout started with Jeffries having everything his own way. In the latter part of the third round he dropped Monroe just as the bell rang. Monroe was dead to the world. Flynn, who was in his corner, picked him up, sat him down, and it was fully 30 seconds before Monroe came to. When Jack's head got clear, Doc told him he had Jeffries beat; all he had to do was just to tear into him when the bell rang, and he would knock him out.

Monroe did just as Flynn told him to and that was the fastest round ever fought in the ring.

Monroe dropped Jeffries to his knees in that round and kept after him until the bell rang. If that round had lasted five minutes Monroe would have knocked Jeffries out.

The papers came out next day stating what a close call the champion had. Monroe got offers from all over the country. Henry Pollack,
